Quality Service Opportunities

- **First Platoon**
 - On May 15, officers located a number of ducklings that were trapped in a city sewer grate. Officers were able to remove the grate and get into the sewer basin to remove the ducklings.
 - On May 21, officers assisted an elderly lady with the removal of a rodent from her kitchen.
 - On May 29, the Canine Team participated in the Frankenmuth Dog Bowl along with other teams from the Saginaw Valley Police Canine Association. This event showcased police canine skills through demonstrations along with meet and greets with the teams. Through the event, the SVPCA raised over \$17,000 for its organization; nearly \$2,000 will directly support the Bay City Department of Public Safety's Canine Team.

- **Second Platoon**
 - Nothing at this time.

Other Agency Assist

- **First Platoon**
 - On May 23, officers assisted the Bay County Sheriff's Department with a subject who fled on foot from a traffic stop. The subject was located by city officers, taken into custody, and turned over to the Sheriff's Department.
 - On May 24, officers checked an address in the city for a person of interest from a homicide that occurred in Iowa City, Iowa. Officers were asked to check the address for a vehicle owned by a subject involved. The subject was not located.
 - On May 25, officers assisted the Bay County Sheriff's Department with a subject that fled on foot while they were attempting to arrest him on a warrant at a residence in the city. The suspect was not apprehended.
 - On May 28, an officer assisted the United States Secret Service with the execution of a search warrant at a residence in the city.

- **Second Platoon**
 - Nothing at this time.

Enforcement Efforts

- **First Platoon**
 - On May 4, an officer stopped a vehicle for a speeding violation. The driver was subsequently cited for operating an unregistered and uninsured vehicle.
 - On May 21, an officer observed a vehicle without a license plate. The vehicle was stopped and found to be unregistered and the driver did not have a license. The driver was cited for no ops never applied and unregistered motor vehicle.

- **Second Platoon**
 - On May 1, an officer stopped a vehicle for disobeying a traffic control device and found that the vehicle wasn't insured or registered, and the driver was suspended. The driver was cited and released at the scene.
 - On May 1, a driver was stopped for disobeying a traffic signal. The driver was found to be operating while intoxicated and was arrested.
 - On May 10, an officer conducted a traffic stop after a driver disobeyed a traffic signal. The driver was processed for operating while intoxicated and subsequently arrested.
 - On May 11, an officer stopped a vehicle for speeding and found that vehicle was uninsured. The vehicle was impounded, and the driver was cited.
 - On May 11, an officer stopped a vehicle for an equipment violation. The officer determined that the driver was suspended and issued a citation.
 - On May 12, an officer conducted a traffic stop on a vehicle for an equipment violation. The driver was found to have an expired license and was cited.
 - On May 18, an officer stopped a vehicle for obstructing traffic in the downtown area and issued a citation for impeding traffic.
 - On May 28, an officer conducted a traffic stop on a vehicle that didn't have a license plate. The driver was issued a citation for driving while license suspended.
 - On May 31, an officer stopped a vehicle for failing to indicate a turn. The driver of the vehicle had a suspended driver's license. The driver was cited and released.

Quality of Life Action Plan

The Quality of Life Action plan was approved and began being tracked on 04/16/21.

- **First Platoon**
 - Officers handled 120 Quality of Life issues for a total of 19 hours and 15 minutes (park checks).
- **Second Platoon**
 - Officers handled 159 Quality of Life issues for a total of 14 hours and 4 minutes (park checks).

Wenonah Park / Downtown Action Plan

- **First Platoon**
 - Officers conducted 17 Wenonah Park / Downtown checks for a total of 2 hours and 27 minutes.
- **Second Platoon**
 - Officers conducted 28 Wenonah Park / Downtown checks for a total of 2 hours and 24 minutes.

Traffic Enforcement Details

- **First Platoon**
 - Green Platoon officers worked traffic enforcement while on patrol for a total of 77 hours and 18 minutes working the following areas: Center Avenue, Columbus Avenue, Eighteenth Street, Fremont Street, Garfield Avenue, Hart Street, North Henry Street, Kosciuszko Avenue, Lafayette Avenue, North Madison Avenue, Marquette Street, McKinley Avenue, Michigan Avenue, Murphy Street, Ninth Street, Saginaw Street, Salzburg Avenue, Seventh Street, State Street, Third Street, Washington Avenue, North Water Street, Twenty-First Street, South Wenona Avenue, and Woodside Avenue.
 - On May 13, Green Platoon officers conducted a traffic enforcement detail on Independence Bridge, focusing on speeding violations. Six vehicles were stopped with five speeding and one driving suspended citation issued.
 - On May 31, Green Platoon officers conducted a traffic enforcement detail in conjunction with the Quality of Life Action Plan in the area of Downtown Bay City & Wenonah Park. There were no violations observed during this detail.

Traffic Enforcement Details continued

- Blue Platoon officers worked traffic enforcement while on patrol for a total of 167 hours and 3 minutes in the following areas: Adams Street, Alp Street, Barclay Street, Birney Street, Broadway Avenue, Columbus Avenue, Dean Street, Farragut Street, Fifth Street, Garfield Avenue, Harrison Street, Henry Street, Jackson Street, Jane Street, Jenny Street, Lafayette Avenue, Linn Street, Madison Avenue, Main Street, Marquette Avenue, McKinley Avenue, Michigan Avenue, Midland Street, Mountain Street, Ninth Street, Raymond Street, Salzburg Avenue, Sherman Street, Truman Parkway, Vermont Street, Warner Street, Washington Avenue, Water Street, Wenonah Avenue, Woodside Avenue, Eleventh Street, Fifteenth Street, Nineteenth Street, Twenty-First Street, Twenty-Ninth Street, and Thirty-Fourth Street.
 - On May 15, Blue Platoon officers conducted a traffic detail in conjunction with the Quality of Life Action Plan in the area of Midland Street and Warner Street. The detail yielded four total traffic stops for speeding, registration violations, and loud car stereo. Officers wrote three citations and issued four verbal warnings.
 - On May 24, Blue Platoon officers conducted a traffic detail in the area of South Madison Avenue and Eighteenth Street focusing on speed enforcement. Six traffic stops for speeding and one for having a loud care stereo were initiated. Four citations were issued, and three verbal warnings given.
- **Second Platoon**
 - Green Platoon officers worked traffic enforcement while on patrol for a total of 103 hours and 45 minutes working the following areas: Third Street, Seventh Street, Eighteenth Street, Broadway Avenue, Cass Avenue, Center Avenue, Garfield Avenue, Henry Street, Jenny Street, Lafayette Avenue, Lincoln Avenue, Madison Avenue, McKinley Avenue, Michigan Avenue, Midland Street, Nebobish Avenue, Park Avenue, North Union Street, Saginaw Street, Salzburg Avenue, Vermont Street, Walnut Street, Water Street, Washington Avenue, Wenona Avenue, Wilder Road, and Woodside Avenue.
 - On May 15, Green Platoon officers performed a traffic detail on North Trumbull Street between Center Avenue and Nebobish Avenue. A total of ten traffic stops were conducted which resulted in nine citations and three verbal warnings.
 - On May 23, Green Platoon officers performed a traffic detail focusing on the Quality of Life Action Plan in the downtown area. They were able to stop two vehicles for minor violations. The detail was terminated early due to a fire related call.
 - Blue Platoon officers worked traffic enforcement while on patrol for a total of 101 hours and 31 minutes working the following areas: Third Street, Seventh Street, Bangor Street, Broadway Avenue, Cass Avenue, Center Avenue, Columbus Avenue, Farragut Street, Fremont Street, Henry Street, Jenny Street, Kosciuszko Avenue, Lafayette Avenue, Lincoln Avenue, Madison Avenue, Marquette Avenue, Midland Street, North Union Street, Salzburg Avenue, Smith Street, State Street, Thomas Street, Washington Avenue, Wilder Road, and Woodside Avenue.

Traffic Enforcement Details continued

- On May 11, Blue Platoon officers conducted a traffic detail in the area of Second Street and North Trumbull Avenue. Officers stopped nine vehicles, issued seven citations, and gave out one verbal warning.
- On May 14, Blue Platoon officers conducted a Quality of Life traffic detail in the area of North Water Street and Fourth Street. Officers stopped eight vehicles, issued three citations, and gave out eight verbal warnings.

Crime Suppression Efforts (Officer Self-Initiated Non-Enforcement Activity to Reduce Crime)

- **First Platoon**
 - Officers completed 165 Park checks totaling approximately 22 hours and 21 minutes.
 - Officers completed 132 actions of “Appeared Secure” for building checks.
 - Officers left door hangers at a total of 56 businesses. Officers recorded checks totaling approximately 6 hours and 51 minutes.
 - Officers continue to complete C.O.P. stops daily during their shift totaling 149 for the month.
- **Second Platoon**
 - Officers completed 186 Park checks totaling approximately 17 hours and 7 minutes.
 - Officers completed 335 actions of “Appeared Secure” for building checks.
 - Officers left door hangers at a total of 213 businesses.
 - Officers recorded business checks totaling approximately 20 hours and 24 minutes spent on checks.
 - Officers are continuing to do C.O.P. stops nightly, totaling 154 for the month.

Detective Bureau Recap

- Officers and Detectives responded to reports of shots fired in the 200 block of South Dean Street. Upon arrival no victims were located, and no one was home. A search warrant was obtained for the apartment which resulted in the location of weapons, ammunition, and drugs. The tenant was eventually located but was uncooperative with the investigation. Charges are being sought for PWID.
- Detectives were called in to assist in the investigation on a shooting that occurred near the corner of Midland Street and South Linn Street. Detectives interviewed a cooperative witness who was able to identify suspects who were involved. Video was obtained which showed the entire incident. One subject, who is currently on parole, has been arrested and arraigned on multiple weapon violations. The other suspect has been identified and is still at large. A warrant request has been sent to the Prosecutor's Office for this subject.

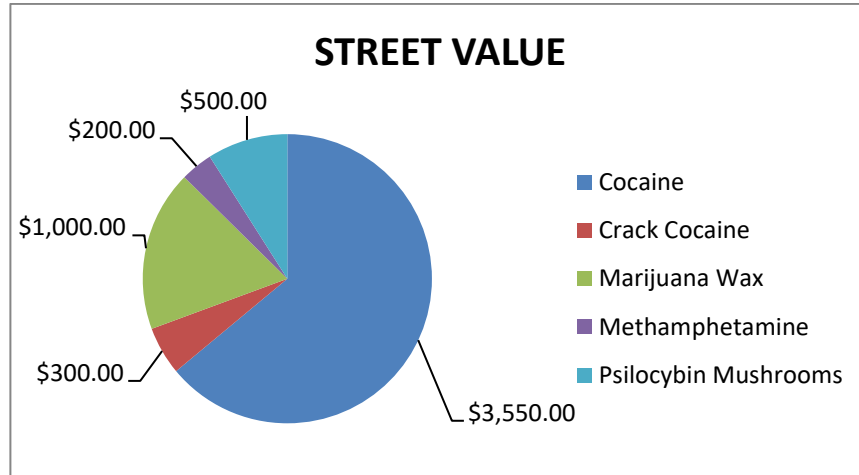

Fire Operations Division



Operational Assignments

- Self-Contained Breathing Apparatus (SCBA) – 30 bottles were filled in May.
- Radios – All radios are operational.
- Hose – Annual hose testing was completed and the recordkeeping document on public drive is being updated.
- Gas Meters – No new information to report.
- Vehicle Maintenance – Engine 1 continued to have a pump leak; issue was being handled by the city barn. Engine 2 continued to have an air leak; the city barn was working on locating and fixing the issue. Engine 4 had a radiator hose issue, which was resolved by the city barn.
- Water/Ice Rescue – Weekly and monthly testing of Boat 1 and equipment completed and in ready condition. Work continued to be done on the new rescue boat for it to be placed into service.
- Station Equipment Checklist – Updated and completed for May.
- Small Tools/Equipment Maintenance – Two handline nozzles were repaired and put back in service.
- Emergency Medical Services (EMS) – PPE stock was in good standing for all items required for safe interactions with the community. Airways were ordered and received.
- Michigan EMS Information System (MI-EMSIS) – May reports were imported to the state properly and we are up-to-date and in compliance.
- Continuing Education Units (CEUs) – All employees were assigned various Target Solutions training segments in May.

Operational Assignments continued

- Central Dispatch/911 Liaison – All units were responding under a revised dispatch protocol eliminating the COVID screening. Our internal response directives were still in effect to limit exposure and conserve PPE. These response directives are in accordance with the state protocol. We continue to work with 911 dispatch on a couple of dispatch performance issues.
- Quality Assurance – NFIRS reports for the month of May were completed; achieved an average of 97% over the 11 categories that are reviewed. Average response time for fire related calls for the month was 4:23.
- SDS Sheets – Books at all stations were current with no updates needed.
- Building Maintenance – The Chimney Doctor cleaned and inspected the chimney at Station 1 and installed a new chimney cap. All the catch basins in the stations were cleaned by the sewer department and four debris catch pans were fabricated and installed in the apparatus bays of the stations.
- Uniforms – Waiting for delivery on a few job shirts that were back ordered.
- Personal Protective Equipment (PPE) – Updated gear inventory in computer database and prepared new round of gear to send out for advanced inspection. Contacted vendor for updated price list. Replaced work gloves and repaired one helmet. Cleaned up gear room and re-organized.
- City-Owned Automatic External Defibrillators (AEDs) – All city owned AED's were accounted for and in good working order.
- Hazardous Materials /Tier II – No new information to report.
- Supplies – An inventory was conducted, and the remaining custodial supplies budget was spent.
- Pre-surveys – No new information to report.
- East Michigan Hazard Mitigation Planning Project – A captain attended the most recent meeting; discussion relevant to our department included constructing and identifying emergency shelters, promoting Integrated Public Alert and Warning System (IPAWS), installing mile markers on the Saginaw River, and increasing investment for the recruiting and staffing of first responders.

Mutual Aid

- The Fire Division provided mutual aid on two incidents in May.
- The Fire Division did not receive mutual aid in May.

Quality Service Opportunities

- There were no quality service opportunities in May.

Regional Response Team 31/Technical Rescue Team (RRT)

- A lieutenant and driver/engineer attended the first part of hazardous materials technician training in Lansing May 10-14.
