The Plan review fee is based on the estimated construction value calculated in accordance with the Permit Fee Schedule (gross area x gross area modifier x type of construction factor) indicated in the latest edition of the Code Official Magazine, published bi-monthly by BOCA International.

#### For buildings with an estimated construction value:

- \$ 0 – 2,500,000 Building review fee is 0.0015 of the estimated value (\$60 min.) (3/14/18)
- \$2,500,000 – 5,000,000 Building review fee is \$3,750 plus .0005 of the estimated value over \$2,500,000
- Over \$5,000,000 Building review fee is \$5,000 plus .0004 of the valuation over \$5,000,000

#### The Plan review fee for mechanical, plumbing and electrical:

Reviews are computed at 25% of the building plan review fee for each discipline (\$60 min.) (3/14/18)

#### The fire sprinkler review fee is based on the number of sprinkler heads:
